

Appendix J: NSLDS Perkins Report File Layout

Appendix J defines the record layout for the NSLDS Perkins By Parameters Report which can be requested on the NSLDS Professional Access web site. Used with Appendix A, Federal Perkins Loans Data Dictionary, each field can be cross-referenced for reporting and business rules.

NSLDS Perkins Extract by Parameters (REC001)

The *Perkins Extract by Parameters (REC001)* provides school users with an extract file containing information on campus-based loans. The user indicates the Desired Loan Statuses for All (every loan regardless of loan status), No Cancelled (all open and closed loan statuses and excludes cancelled loan status), Open (every loan with an open loan status), or Open-Pending Transfers Only (all open loans where a transfer has been initiated by the school but not picked up by the ED Servicer). The user also chooses the Extract By Data Provider ID which is a unique loan identifier optionally assigned to a student by the awarding school. Users can select All, With Provider, Without Provider. The report output is sorted by SSN, DOB, and First Name. The report is delivered to the SAIG mailbox (TG Number) associated with the User ID requesting this report, under message class SCHRECOP. This report can be requested both on an ad-hoc and scheduled basis, through navigating to the "Perkins" Folder in the NSLDS Reports Tool found by clicking on the "Reports" link in the NSLDS Professional Access Web site.

The following sections contain the layout of the records for the extract output. The record layout tables contain the position, the data element name, description, field format, and field length, as they will appear on the extract.
