In addition to the annual 2025–26 system updates that we will implement in October 2024, we plan to release other system updates intermittently. Scheduling intermittent releases enables us to continuously improve our websites and other systems.

September 3, 2024	Federal Student Aid announced the availability of the <a href="#">2025–26 FAFSA Prototype</a> . The FAFSA prototype is not a complete replica of the 2025–26 FAFSA form that will be available on fafsa.gov. Instead, it's a web-based design tool that allows users to navigate specific scenarios that many 2025–26 applicants will encounter on the live website.
September 3, 2024	The Secretary of Education announces the <a href="#">annual updates to the tables used in the statutory “Federal Need Analysis Methodology”</a> to determine an applicant’s Student Aid Index (SAI) for the 2025–26 processing cycle.
September 17, 2024	Federal Student Aid announced the availability of a <a href="#">small file of ISIRs for system testing</a> . This file contains three records: one for a dependent student, an independent student, and a provisionally independent student.

Date	Event
October 1, 2024	Federal Student Aid released the 2025–26 online FAFSA form and ISIR processing for testing with a limited set of students and institutions. During the testing period, the form will be available to an increasing number of participants, starting with hundreds and expanding to tens of thousands of applicants. This process will allow Federal Student Aid to test and resolve issues before making the form available to all students and contributors.
October 1, 2024	The 2025–26 FAFSA Partner Portal ( <a href="https://fafsa.partnerportal2526.ed.gov">fafsa.partnerportal2526.ed.gov</a> ) is available to FAAs. This release includes Applicant View and Corrections.
October 7, 2024	FSA announces the availability of the <a href="#">2025–26 FAFSA Specifications Guide, Volume 7 – Comment Codes</a> , which supplies the comment codes, comment text, and reject resolutions.
October 8, 2024	FSA announces the availability of the <a href="#">2025–26 FAFSA Specifications Guide, Volume 1 – Summary of Changes</a> , which describes the changes to the FPS for 2025–26.
October 16, 2024	FSA announces the availability of the <a href="#">2025–26 FAFSA Specifications Guide, Volume 8 – Agency Matches</a> , which describes Agency match results and resulting comments.
October 16, 2024	Federal Student Aid announces the availability of the <a href="#">2025-26 EDEExpress for Windows Packaging Technical Reference</a> . This technical reference provides instructions and record layouts for schools and other organizations that need to integrate their software or systems with the EDEExpress 2025–26 Packaging module. Mid-September 2025	The FPS accepts 2024–25 paper and online corrections until mid-September 2025. Watch for a <a href="#">Federal Register notice</a> containing more information about this deadline. Electronic corrections must be transmitted to and received by the FPS by midnight CT to meet the deadline.
Late June 2026	The FPS accepts 2025–26 paper and online FAFSA forms until late June 2026. Watch for a <a href="#">Federal Register notice</a> with the final deadline. Electronic FAFSA forms must be transmitted to and received by the FPS by midnight CT to meet the deadline.
Mid-September 2026	The FPS accepts 2025–26 paper and online corrections until mid-September 2026. Watch for a <a href="#">Federal Register notice</a> containing more information about this deadline. Electronic corrections must be transmitted to and received by the FPS by midnight CT to meet the deadline.

# Mailing Addresses

The mailing addresses for 2025–26 are updated. English and Spanish versions of the forms are sent to the same mailbox based on the applicant type, which include a regular applicant, an incarcerated applicant, and an applicant 13 and younger who is protected by the Children’s Online Privacy and Protection Act (COPPA).

**New for 2025–26:** The mailbox numbers for the regular and incarcerated applicants are new. There is no change to the mailbox used for COPPA protected applicants. Also, there is no change to the mailbox to submit the Revocation of Consent form.
