## **Death Status Conflict Report Extract File Layout (DSCGA1 & DSCGA2)**

The *Death Status Conflict Report* provides Guaranty Agency (GA) users with an extract of borrowers who have a loan in an open status at the specific entity, and also have at least one loan in a death status at any entity. The extract also includes beneficiaries (student) of Parent PLUS loans with loan status code of “PZ” (PLUS Child Death) and loan status effective date within the last five years. The report can be requested ad-hoc, through the Report List link under the Report tab of the NSLDS Professional Access website, or scheduled through the Organization Profile link under the Org tab.

The report (ad-hoc and scheduled) is available in Fixed-Width or Comma Separated Values (CSV) format, and is delivered via SAIG using the following message classes:

- DERPFWOP – Fixed-Width format
- DERPCDOP – Comma Separated Values format

Each report request will generate one header record, one or more detail records, and one trailer record.

This document contains the record layouts for both the Fixed-Width and CSV formats of the output. For the Fixed-Width format, the record layout tables contain the position, data element name, description, field format, and length of each field. For the CSV format, the record layout tables contain the data element name, description, and field format of each field.

### **Requesting the Ad-hoc Report (Report ID = DSCGA1)**

The user may choose the extract type of Fixed-Width or CSV. The report output is sorted by SSN, and delivered to the SAIG mailbox associated with the requesting user.

### **Requesting the Scheduled Report (Report ID = DSCGA2)**

Unlike the ad-hoc reports, scheduled reports are delivered automatically according to the frequency selected. Available frequencies are monthly and quarterly. The user who sets up scheduling may choose to receive the extract in either Fixed-Width or CSV format. The scheduled report will be sent to the SAIG mailbox (TG number) specified by the user.
