Our federal offices as well as some of our Title IV processors and call centers will be closed on Wednesday, July 4, 2012 to observe the Independence Day federal holiday. See below for the various centers' operation status on the holiday.

CPS

The Central Processing System (CPS) will accept data on Wednesday, July 4, 2012 but will not process new Institutional Student Information Records (ISIRs) until Thursday, July 5, 2012.

COD System

The Common Origination and Disbursement (COD) System will accept and process data from schools and send back responses/acknowledgments on Wednesday, July 4, 2012, but schools will not be able to receive any federal funds on that day. Requests for changes in funding levels and for funds will not be processed until Thursday, July 5, 2012.
