#### **End of Federal Fiscal Year 2009 – Impact on Funds Availability [09/03/09 (Updated 10/02/09)]**

As explained in a [September 2, 2009 Electronic Announcement posted on the Information for Financial Aid Professionals \(IFAP\) Web site](#), September 30, 2009 marked the end of the Federal fiscal year for the Department of Education (the Department). Some of the Department's core financial systems, including G5, were on a modified processing schedule while the Department finalized its processing and accounting for Fiscal Year 2009.

The Department is pleased to report the successful completion of this work and the availability of G5. The Department appreciates schools' patience and understanding as it completed the required activities. All financial processing is expected to be caught up by Monday, October 5, 2009.


For Grant and Direct Loan Participants—

### Current Issues

#### **Pnote/ATS Linking Issue (09/28/09)**

Federal Student Aid has discovered a linking issue where Direct PLUS Loan Master Promissory Notes (MPN) are not immediately linking to corresponding Direct PLUS Loan awards. This issue occurs even when the borrower's and/or student's SSN, DOB, and first two letters of the first name matches. **Note:** This issue also affects the linking process for 2009-2010 Agreements to Serve (ATS) and TEACH Grant awards.

Instead, the linking occurs during weekend processing or when a school submits a subsequent change to the award or submits an actual disbursement. As a result, "linked" MPN or ATS acknowledgements are delayed by several days and the change to the award or the actual disbursement is rejected (the award change or disbursement usually accept once resubmitted).

Federal Student Aid is researching the cause of this issue and will provide updates as more information becomes available. We apologize for any inconvenience this issue causes schools. If you have questions about this issue, contact the COD School Relations Center.

#### **Sending Addresses for U.S. Territories on the Common Record or the COD Web site (10/02/09)**

When submitting student or borrower addresses to the Common Origination and Disbursement (COD) System, it is important that the correct tags are used, particularly when the student or borrower address is located in a U.S. Territory. These addresses are considered domestic addresses and should not be submitted as a foreign address with a Country Code. If these addresses are not submitted correctly, important correspondence from the COD System and the Direct Loan Servicing Center is delayed or not received.

When a student or borrower address is located in a U.S. Territory, the address should be treated as a domestic address and submitted to the COD System as follows:

**COD Computer-Based Training (10/02/09)**

Federal Student Aid takes this opportunity to remind the community of the availability of the COD Computer-Based Training (CBT). The COD CBT includes enhancements that have been made to the COD System, the [COD Web site](#), and associated Web sites and software products through June 28, 2008.

The COD CBT consists of component simulations and CBTs. Each COD CBT component is explained below. The electronic files associated with each component, as well as information about downloading and navigating the COD CBT, are available on the Information for Financial Aid Professionals (IFAP) Web site. Under the “Tools for Schools” section on the home page, click on [COD Computer-Based Training](#).

The components of the COD CBT are as follows:



***COD System Simulations*** – The COD System Simulations offer lessons that explain the [COD Web site](#) screens and functionality available to a school administrator. There are 14 lessons (one with two parts) with text to guide a user through each area of the [COD Web site](#). By entering fictitious data, the user can explore basic navigation and functions of the [COD Web site](#) and practice locating and creating information in a safe environment that includes tips for assistance.

***Direct Loan Reports CBT*** – The Direct Loan Reports CBT includes three lessons that explain the COD reports a school can use to assist with the reconciliation process for William D. Ford Federal Direct Loan (Direct Loan) awards.

***Grant Reports CBT*** – The Grant Reports CBT includes three lessons that explain the COD reports a school can use to assist with the reconciliation process for Federal Pell Grant (Pell Grant), Academic Competitiveness Grant (ACG), and National Science and Mathematics Access to Retain Talent Grant (National SMART Grant) awards.

***Direct Loan (DL) Tools Simulation*** – The DL Tools Simulation demonstrates how to use the DL Tools software to assist with the reconciliation process for Direct Loan awards. Although the simulation can be used both by schools that use the EDEExpress for Windows software and schools that do not use this software, the simulation is especially useful for schools that do not use the EDEExpress software on a regular basis but are interested in a Direct Loan reconciliation resource.

***eMPN Online Simulations*** – The eMPN Online Simulations offer a step-by-step walk through of the process for completing a Direct Loan Master Promissory Note (MPN) via the [Direct Loan Electronic MPN Web site](#). There are three lessons with text to guide a user through student and parent aspects of the eMPN process.

As explained in a [September 2, 2009 Electronic Announcement posted on the Information for Financial Aid Professionals \(IFAP\) Web site](#), September 30, 2009 marked the end of the Federal fiscal year for the Department of Education (the Department). Some of the Department's core financial systems, including G5, were on a modified processing schedule while the Department finalized its processing and accounting for Fiscal Year 2009.

The Department is pleased to report the successful completion of this work and the availability of G5. The Department appreciates schools' patience and understanding as it completed the required activities. All financial processing is expected to be caught up by Monday, October 5, 2009.

#### **2008-2009 ACG, National SMART Grant, and Pell Grant Processing Deadline (10/1/2009)**

The deadline for electronically transmitting Academic Competitiveness Grant (ACG), National Science and Mathematics Access to Retain Talent Grant (National SMART Grant), and Federal Pell Grant (Pell Grant) records for the 2008-2009 Award Year to the COD System was **Wednesday, September 30, 2009.**

From October 1, 2009 and forward, the COD System will accept and reject 2008-2009 ACG, National SMART Grant, and Pell Grant data as follows:

#### ***ACG and National SMART Grant Programs***

- Accept and process decreases to previously accepted 2008-2009 award originations and decreases to previously accepted 2008-2009 disbursements.
- Accept and process originations and disbursements of new 2008-2009 awards or 2008-2009 award amount increases only if the Department has granted Administrative Relief or Extended Processing for the 2008-2009 Award Year.

#### ***Pell Grant Program***

- Accept and process decreases to previously accepted 2008-2009 award originations and decreases to previously accepted 2008-2009 disbursements.
- Accept and process originations and disbursements of new 2008-2009 awards or 2008-2009 award amount increases only if 1) the student was in a Potential Overaward Process



(POP) situation during the 2008-2009 Award Year or 2) the Department has granted Administrative Relief or Extended Processing for the 2008-2009 Award Year.

**Notes:**

- 1) Unless one of the situations outlined above applies, the COD System will reject originations and disbursements of new 2008-2009 awards or 2008-2009 award amount increases and return COD Edit 43 (New Award Amount or Award Increase Received After End of Processing Year and Institution has Not Been Granted Extended Processing) or COD Edit 71 (New Disbursement Increase, or Disbursement Release Indicator to “True” Received After End of Processing Year and Institution Has Not Been Granted Administrative Relief).
- 2) In accordance with the allowable timeframe for submitting verification documentation/completing the verification process as specified in [the “Notice of Deadline Dates for Receipt of Applications, Reports, and Other Records for the 2008-2009 Award Year” published on June 18, 2009 \(74 FR 28918\)](#) in the Federal Register, the COD System will no longer accept “W” as a valid verification status code for 2008-2009 Pell Grant awards. The COD System will return COD Reject Edit 114 (Disbursement or Disbursement Adjustment received after Verification Status W Deadline Date).

### **Reminder of Citizenship Status Code Processing for ACG, National SMART Grant, and Pell Grant Awards (09/02/09)**

As explained in a [March 20, 2009 Electronic Announcement posted on the Information for Financial Aid Professionals \(IFAP\) Web site](#), the COD System was updated to apply more consistent edit logic for the Citizenship Status Code for ACG, National SMART Grant, and Pell Grant awards. The Citizenship Status Code will be evaluated in the same manner across all the grant programs.

The Citizenship Status Code field on the Common Record is the primary source of evaluation for student's citizenship. If the Citizenship Status Code is not populated with a "1" (citizen) or a "2" (eligible non-citizen) by the institution on the incoming origination record, the COD system must determine the student's citizenship status based on the data matches supplied through the Central Processing System (CPS). The COD System does not evaluate based on the student reported citizenship status on the FAFSA, only the verified citizenship data match that was done through either the Social Security Administration (SSA), or the Department of Homeland Security (DHS).

If the Citizenship Status Code field is not populated on the incoming origination records, the COD System will now evaluate the values from the SSA Citizenship Flag match field, and if necessary, the DHS Match Flag field and the Secondary DHS Match Flag field supplied through CPS. If the student's citizenship status can be determined from these sources, the COD System



will accept and build the record. If it cannot be determined from these sources, the COD system will reject the award with Edit 14 (Citizenship Status is not eligible for this award.) **Note:** If the citizenship status is determined by using the CPS data, it will be stored on the COD System, but will not be returned on the Common Record response.

Schools should refer to Volume II, Section 1 of the [2009-2010 Common Origination and Disbursement \(COD\) Technical Reference](#) for complete operational information about citizenship status code processing.

By entering fictitious data, the user can explore basic navigation and functions of the [COD Web site](#) and practice locating and creating information in a safe environment that includes tips for assistance.

***Direct Loan Reports CBT*** – The Direct Loan Reports CBT includes three lessons that explain the COD reports a school can use to assist with the reconciliation process for William D. Ford Federal Direct Loan (Direct Loan) awards.

***Grant Reports CBT*** – The Grant Reports CBT includes three lessons that explain the COD reports a school can use to assist with the reconciliation process for Federal Pell Grant (Pell Grant), Academic Competitiveness Grant (ACG), and National Science and Mathematics Access to Retain Talent Grant (National SMART Grant) awards.

***Direct Loan (DL) Tools Simulation*** – The DL Tools Simulation demonstrates how to use the DL Tools software to assist with the reconciliation process for Direct Loan awards. Although the simulation can be used both by schools that use the EDEXpress for Windows software and schools that do not use this software, the simulation is especially useful for schools that do not



use the EDEXpress software on a regular basis but are interested in a Direct Loan reconciliation resource.

**eMPN Online Simulations** – The eMPN Online Simulations offer a step-by-step walk through of the process for completing a Direct Loan Master Promissory Note (MPN) via the [Direct Loan Electronic MPN Web site](#). There are three lessons with text to guide a user through student and parent aspects of the eMPN process.

The College Cost Reduction and Access Act (the CCRAA), Pub. L. 110-84, authorized the Teacher Education Assistance for College and Higher Education (TEACH) Grant Program beginning with the 2008-2009 Award Year.

On June 3, 2008, the Department of Education posted [Dear Colleague Letter GEN-08-07 on the Information for Financial Aid Professionals \(IFAP\) Web site](#). This Dear Colleague Letter clarifies how an institution will establish eligibility to participate in the TEACH Grant Program.

**Participation Request Process Steps** – As outlined in the 10-step participation request process included in [Dear Colleague Letter GEN-08-07](#), a school must complete Question 1, enter specified language in Section K/Question 69, and complete Section L via the [E-App Web site](#). After completing these steps, the school must mail its signed and dated signature page to the Department of Education (the Department) per the instructions provided on the “Submit Application” page. To aid in expediting receipt of the school's signature page by the Department, the school may want to use an overnight delivery method.

**Participation Request Process Follow Up** – If a school does not receive a response regarding its request to participate in the TEACH Grant Program within two weeks of submitting the request, the school should contact the School Participation Team for the school's state. Contact information is available on the [E-App Web site](#).

**School Addition to ATS Web Site** – Once a school is determined to be eligible to participate in the TEACH Grant Program, the school's name will be added to the TEACH Grant Agreement to Serve (ATS) Web site. As a general rule, Federal Student Aid will update the TEACH Grant ATS Web site on the Tuesday or Thursday most closely following notification of the school's eligibility.
