As explained in earlier announcements on [the Information for Financial Aid Professionals \(IFAP\) Web site](#), Federal Student Aid began assigning FFEL Purchased Loans to four new servicers in early September 2009. Each year, Federal Student Aid will measure the performance of these servicers in the areas of customer satisfaction and default aversion.

An independent vendor plans to begin conducting telephone surveys of borrower and school customers during the first week of December 2009. NSLDS Identification Information and New School Report for FFEL Purchased Loans (11/25/09)

As explained in earlier announcements on [the Information for Financial Aid Professionals \(IFAP\) Web site](#), Federal Student Aid explained our transition to additional servicer support for loans that the Department of Education (the Department) owns. The announcements also explained that upon assignment of a FFEL Purchased Loan to one of these servicers the borrower receives correspondence that identifies the servicer and provides its contact information. In addition, the servicer's information is available in the National Student Loan Data System (NSLDS) within seven to ten business days after the loan has been assigned to the servicer.

To date, an individual lookup needed to be done via the appropriate NSLDS Web site ([NSLDS Student Access Web site](#) for students or [NSLDS Professional Access Web site](#) for schools). Individual lookups are still an option; however, a new "Status of Loans Purchased by ED Report" (PLPED3) is also now available for school use.

COD School Testing for the 2010-2011 Award Year (11/23/09)

The Common Origination and Disbursement (COD) School Relations Center will conduct Common Record Manual Verification and Structured Application Testing for the 2010-2011 Award Year from January 4, 2010 through June 25, 2010. Optional Unstructured Testing will be available June 7, 2010 through October 1, 2010.

The purpose of COD School Testing is to provide schools, third party servicers, and software vendors an opportunity to test Academic Competitiveness Grant (ACG), National Science and Mathematics Access to Retain Talent Grant (National SMART Grant), Federal Pell Grant (Pell Grant), Teacher Education Assistance for College and Higher Education (TEACH Grant), and William D. Ford Federal Direct Loan (Direct Loan) business processes and system software with the COD System prior to the transmission and processing of actual production data using [COD Common Record XML Schema Version 3.0c](#). It also allows schools, third party servicers, and software providers the opportunity to make corrections or enhancements to software applications and processes prior to sending data to the “live” production environment.

All entities that wish to participate in COD School Testing must submit the “COD School Testing 2010-2011 Sign-Up Document” to the COD School Relations Center. Schools, third party servicers, and software vendors can submit the sign-up document beginning Monday, December 7, 2009.

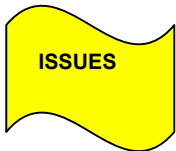

Sending Addresses for U.S. Territories on the Common Record or the COD Web site (11/25/09)

When submitting student or borrower addresses to the Common Origination and Disbursement (COD) System, it is important that the correct tags are used, particularly when the student or borrower address is located in a U.S. Territory. These addresses are considered domestic addresses and should not be submitted as a foreign address with a Country Code. If these



addresses are not submitted correctly, important correspondence from the COD System and the Direct Loan Servicing Center is delayed or not received.

When a student or borrower address is located in a U.S. Territory, the address should be treated as a domestic address and submitted to the COD System as follows:

There are three separate simulations: one for completing a Direct Subsidized/Unsubsidized Loan MPN, one for graduate students completing a Direct PLUS Loan MPN, and one for parents completing a Direct PLUS Loan MPN. Each simulation uses text to guide a user through student and parent aspects of the electronic MPN process.

TEACH Grant Operational Implementation Guidance – COD System Implementation and Guidance Summary (11/25/09)

The College Cost Reduction and Access Act (the CCRAA), Pub. L. 110-84, authorized the Teacher Education Assistance for College and Higher Education (TEACH) Grant Program beginning with the 2008-2009 Award Year.

TEACH Grant – Institutional Participation Request Process Information (11/25/09)

On June 3, 2008, the Department of Education posted [Dear Colleague Letter GEN-08-07 on the Information for Financial Aid Professionals \(IFAP\) Web site](#). This Dear Colleague Letter clarifies how an institution will establish eligibility to participate in the TEACH Grant Program.

For complete information about the Institutional Participation Request Process, refer to [Dear Colleague Letter GEN-08-07](#).

Participation Request Process Steps – As outlined in the 10-step participation request process included in [Dear Colleague Letter GEN-08-07](#), a school must complete Question 1, enter specified language in Section K/Question 69, and complete Section L via the [E-App Web site](#). After completing these steps, the school must mail its signed and dated signature page to the Department of Education (the Department) per the instructions provided on the “Submit Application” page. To aid in expediting receipt of the school's signature page by the Department, the school may want to use an overnight delivery method.

Participation Request Process Follow Up – If a school does not receive a response regarding its request to participate in the TEACH Grant Program within two weeks of submitting the request, the school should contact the School Participation Team for the school's state. Contact information is available on the [E-App Web site](#).

School Addition to ATS Web Site – Once a school is determined to be eligible to participate in the TEACH Grant Program, the school's name will be added to the TEACH Grant Agreement to Serve (ATS) Web site. As a general rule, Federal Student Aid will update the TEACH Grant ATS Web site on the Tuesday or Thursday most closely following notification of the school's eligibility. If a school has questions about the TEACH Grant ATS Web site, it should contact the COD School Relations Center.
