## Overview

New text additions in EDE Technical Reference change pages are identified with ***bold italic*** text. Text deletions are marked with ~~striketrough~~.

When a section of the EDE Technical Reference is modified through a change page release, the footer on each page of the modified section is updated to reflect the month that the change pages were issued. For example, if a change is made to page 1-12 in November 2009, all pages in section 1 will show “November 2009” in the footer. Use the corresponding tracking log to identify what was revised in the section as part of a specific month’s change page posting.
