1.0 NSLDS Usage Summary Extract File Layout (SECUS1)

The *Usage Summary Report* (SECUS1) provides the Department of Education and the Primary Destination Point Administrator (PDPA) a list of an organization's online users and their National Student Loan Data System (NSLDS) activity. Divided into two sections, the first section identifies users with active access and provides the date last logged on, average number of hours per day logged on, number of borrowers accessed, the date of the last security acknowledgement training, the number of logons, and the number of session takeovers. The second section identifies information of those online users who are suspended or deactivated and provides the date and reason. If NSLDS sent more than one e-mail for the same type of security issue, it is only listed once. Data is timeframe specific based on the beginning and end date parameters entered. Sort options include User ID and Last Name/First Name.

This section contains extract file layouts that list the header, details, and trailer records for the extract version of the report. Each online extract request is used to generate one header record, one or more detail records, and one trailer record. Each record layout table contains the position, the data element name, description, field format, and length.
