NSLDS is pleased to announce improved and new reports for schools, guaranty agencies and ED users. These reports can be requested on an ad hoc basis under the Report tab on the NSLDSFAP Web site. NSLDS collected recommendations from the school and guaranty agency communities to develop reports that extract NSLDS data and can be used to help manage business functions. Some of the older reports that extracted information that can now be viewed on the Web were removed. School and guaranty agency users download the reports from their SAIG mailbox. ED users download the reports from their SAIG mailbox, TSO Download, or RMDS.

## School Reports

The Exit Counseling reports were improved. Schools now have the ability to request up to 50 borrowers at a time instead of six on the Exit Counseling by SSN Report (SCH01A). The next report, Exit Counseling Report (SCH01B for school users and SCH01C for ED users), extracts borrowers based on the input of an anticipated completion data range (ED users are required to input an OPEID). The report has been modified to accept any date range provided. Both reports return only open loans. These reports supply the necessary information for exit counseling. These reports are now available in both the extract and the preformatted report formats.

The Financial Aid Transcript Report (FAT001) was designed for schools that want a full financial aid history on students by simply requesting one from our Web site. The output includes aggregate loan, overpayment, individual loan, and specified award year Pell grant information for the requested student. The report is available in both extract and preformatted report formats.

The School Overpayment Report (OVP001 for school users and OVP002 for ED users) provides users with a list of overpayments stored on NSLDS for the requested school. The report identifies the user who entered each overpayment. Users can pick an overpayment type and overpayment indicator (or 'All' to list overpayments of all types), specify one of three sort orders, and choose whether to receive the information as a formatted report or an extract file. Optionally, the user can specify a range of overpayment create dates by entering begin and end dates. The report is available in both extract and preformatted report formats.

The Date Entered Repayment Report (DER001 for school users and DER002 for ED users) allows users to enter a date range and receive a list of student borrowers with loan history who are scheduled to go into repayment during the specified date range. Borrowers returned will be in current attendance at the requestor's school (ED users are required to input an OPEID). The report will be available in both extract and preformatted report formats. It will be available in July.

The Enrollment Reporting Summary Report (SCHER1 for school users and SCHER2 for ED users) provides users with a chronology of enrollment reporting events. Users input a date range (ED users are required to input an OPEID). The report provides information on when a roster was sent, school updates, type of update, number of valid records, error records, total records, transfer records and correction records. It is available only in a preformatted report format.

## Guaranty Agency Reports

The enhanced Loan Profile Data by SSN Report (GA005A) allows GA users to request a complete loan history for up to 50 borrower SSNs. In the past a GA user could request only six borrower's SSNs. The requesting GA must have guaranteed at least one of the borrower's loans. The information is available in both extract and preformatted report formats.

A new report for Guaranty Agencies is the GA Top Ten Error Report (GAERR2), which allows a GA user to request a list of their own monthly error rates and a list of the top ten errors for the month. It is available only in a preformatted report format.
