# Emerging Patterns of Non-traditional Education



*OPE*

- Self-paced Learning
- Sequential Course Enrollment
- Overlapping Terms
- Weekend Degree Programs
- Multiple Start Dates
- Combinations of On-campus and Distance Study
- New possibilities for home/host school enrollments

# Campus Systems

- Separate "On-campus" and Continuing Education Systems
- Structured Around Terms
- Inability to Customize
- Organized to meet Institutional, not Student Needs



# What's Not the Problem

- Distance Education per se (under 50% levels)
- Non-traditional Education provided in Standard Terms

# Term - Characteristics



*OPE*

- Has a defined beginning date and a defined ending date
- Students generally complete the credits for which they are enrolled within that time period



# Standard Term - Characteristics

## ■ Semester or Trimester

- Approximately 15 weeks long
- Full-time is at least 12 hours
- Academic calendar is 3 terms - Fall, Spring and Summer

## ■ Quarter

- Approximately 10-12 weeks long
- Full-time is at least 12 hours
- Academic calendar is 3 quarters in fall, winter and spring and often a Summer quarter as well

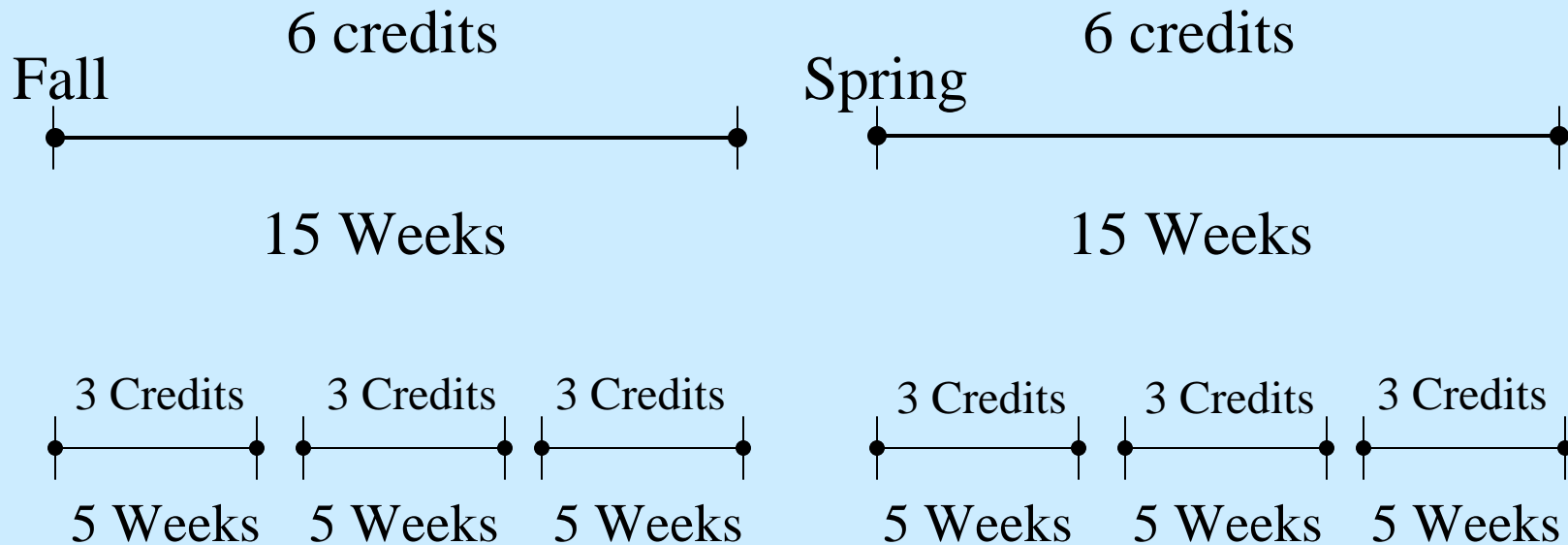

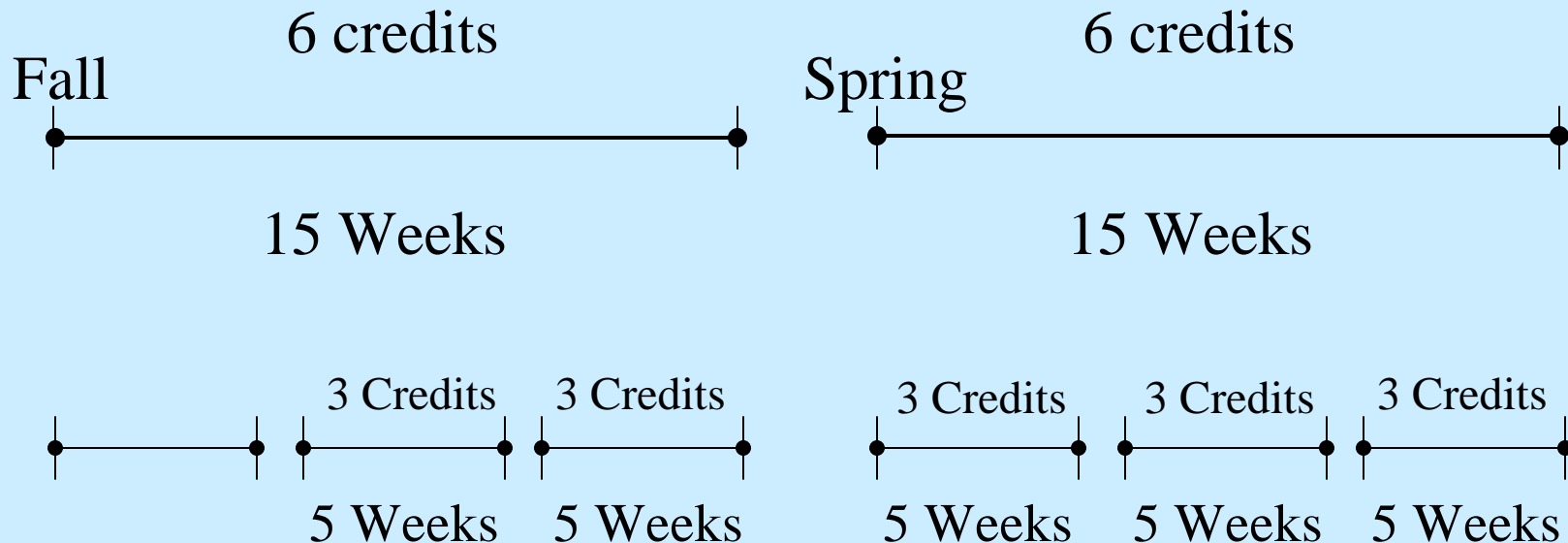

# Non-standard Term - Characteristics



*OPE*

- Is not a semester, trimester or quarter
- Could be terms of differing lengths or terms that are the length of a quarter but which measure progress in semester credit hours

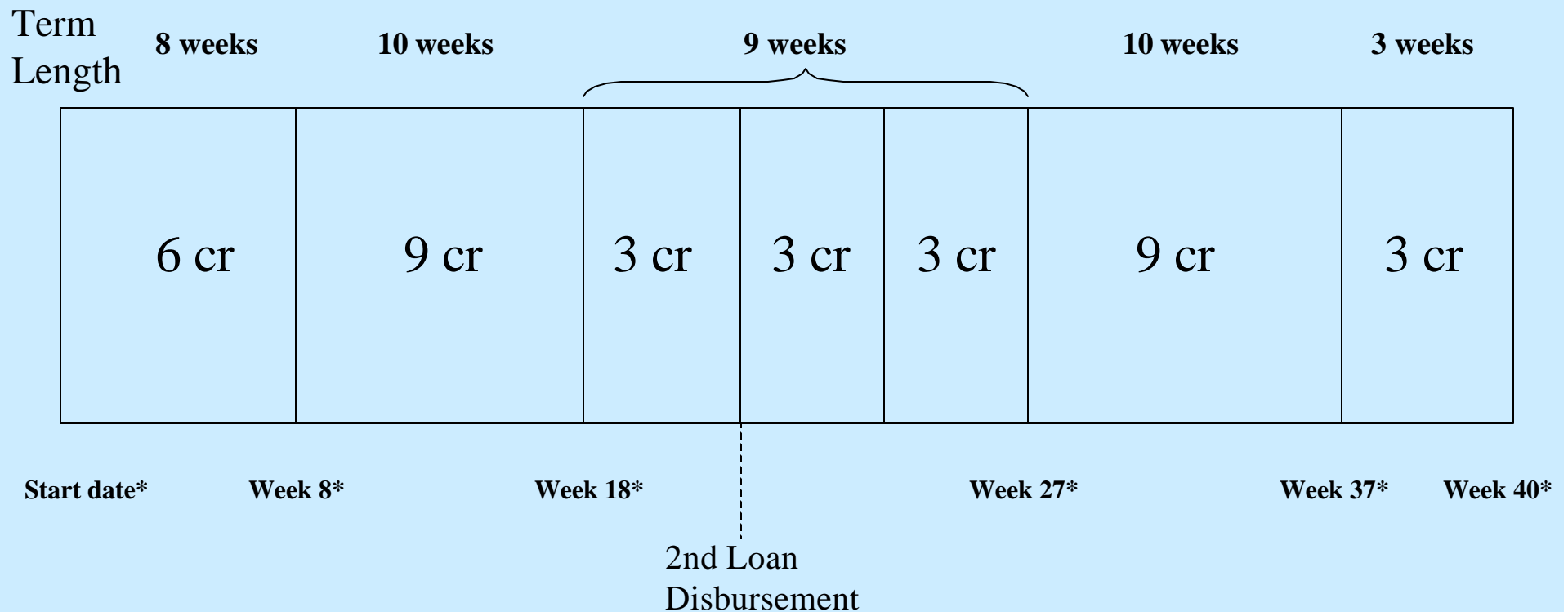

# Non-standard Term - Vocational Certificate Program



**OPE**

Loan certified for 37 weeks



\*Pell disbursements each nonstandard term

# FT Enrollment Status for each Payment Period



**OPE**

Number of credit hours in the academic year      x       $\frac{\text{Weeks of instructional time in the payment period}}{\text{Weeks of instructional time in the academic year (as defined by the institution)}}$  = Full-time enrollment status

$$\frac{24 \times 8}{30} = 6.4 \text{ cr} \quad \text{Round up to 7 semester credits required for full-time}$$

$$\frac{24 \times 10}{30} = 8 \text{ cr}$$

$$\frac{24 \times 3}{30} = 2.4 \text{ cr} \quad \text{Round up to 3 semester credits required for full-time}$$

# Pell Calculations for Non-standard Term



**OPE**

$$\text{Annual Award} \quad \times \quad \frac{\text{Weeks of instructional time in the payment period}}{\text{Weeks of instructional time in the academic year (as defined by the institution)}} = \text{Payment for the payment period}$$

$$\$2,475 \quad \times \quad \frac{8}{30} = \$660$$

$$\$3,300 \quad \times \quad \frac{10}{30} = \$1,100$$

$$\$3,300 \quad \times \quad \frac{3}{30} = \$330$$

# Non-term - Definition

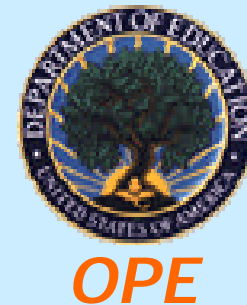
- Does not meet the definition of a term
- Could include self-paced programs or sequential coursework



# Statutory and Regulatory Provisions Governing Non-term Programs

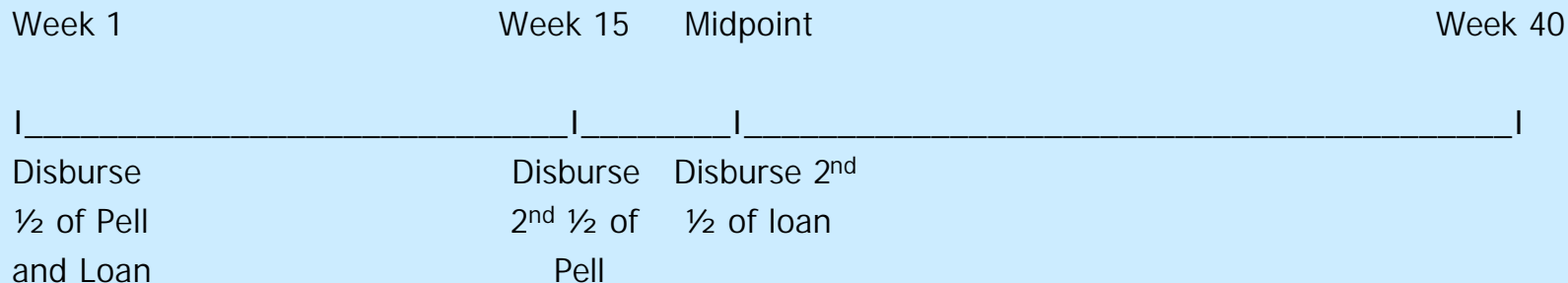


- 12 Hour Rule -- 30-week Academic Year or Longer
- Payment Period
- Calculation of Enrollment Status
- Loan Certification
- Pell Formula IV
- Track Progress

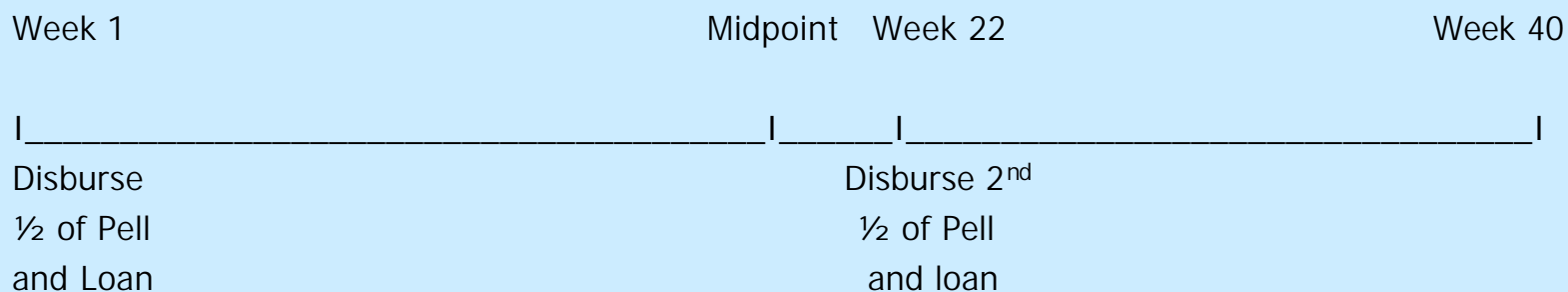


# Non-term Bachelor's Degree Completion Program - Self Paced

**Example 1 -- Student completes 12 semester credits in 15 weeks of a 40-week academic year.**



**Example 2 – Student does not complete 12 semester credits until week 22.**





# Reminders

- 30-week Academic Year = 30 Weeks of Instructional Time
- The 12-hour rule may apply to some of your programs
- Many institutions which are predominately standard term based may also offer vocational programs that are less than a year in length
